**RETAIN CIM-II SNY, CPP**

Inmate [REDACTED] appeared before the California Institution for Men, Level II SNY (CIM-II SNY), Unit Classification Committee today for his Annual/Transfer Review. [REDACTED] received his 72-hour notice for the purpose of this review. The CDC-812, 127, 840, confidential, STG and MSF Screening Forms have been completed, reviewed and/or updated.

This review period covers 7/18/2013 through 7/15/2014. Classification Score remained unchanged at 19 due to LIFE sentence, with two periods of Positive programming noted. CDCR-128G dated 2/7/2012 lists full case factors. The following information has been processed/updated since: [REDACTED] is currently assigned in the [REDACTED].

CSRA noted as 1, COMPAS NOT completed LIFER. SNY placement is due to not wishing to participate in prison politics according to 128B dated 6/23/2011 and remains appropriate.

Per Population Management Unit directive and statewide need of HRM beds, [REDACTED] was looked as a potential non-adverse transfer. Due to [REDACTED]'s IPEP training, his current job position [REDACTED] and his BPH being within the next 6 months, [REDACTED] is NOT being placed up for transfer.

Based upon a review of [REDACTED]'s Central File, case factors, and through discussion with him, committee elects to: **RETAIN CIM-II SNY, CPP.**

Per CCR 3177, [REDACTED] is NOT ELIGIBLE for Family Visiting due to life sentence. [REDACTED] is Eligible for Contact Visiting without restrictions.

[REDACTED] was reviewed in accordance with Double Cell/Dorm housing criteria. After an extensive interview with the Inmate and a review of all present documentation, he does meet Double Cell/Dorm housing criteria in that he does not and has not demonstrated significant in-cell/dormitory physical or sexual violence against a cell partner and is not known to be the victim of such violence.

The CDCR 1882 was reviewed and DDPS IHC code of RE remain current.

At the conclusion of this review, [REDACTED] was informed of his Appeal Rights with regards to this committee's actions. During the pre-committee interview, [REDACTED] acknowledged his understanding and agreed with committee's actions.
